**Commissioners Discussion:**

Richard Lamkey introduced landscape architect, Gary Blanford, principle of Blanford Design. Gary presented the Park Board with a proposal to provide a Landscape Development Plan for the Spring Lake Equestrian Trail Head Parking lot. A preliminary concept drawing was presented to the Commissioners. The Park Board walked the parking lot area as presented in the plan and discussed various issues.

Commissioners discussed the requirements needed to for the Spring Lake Equestrian Trail Head, project RTP 09-62. Gary was provided with a copy of the Recreational Trails Program Grant Project Agreement, Recreational Trails Grant Program Development Project Implementation and Billing Requirements and will be sent a sample template for construction projects and bid notices for the newspaper.

Richard attended the last Advisory Committee meeting and discussed the parking lot concept with the Advisory Committee.
